# "Modern Trends and Challenges of Public Service in Post-Soviet and transition countries"

## 2019 ASPA Annual Conference

### Background:

Over the last three decades, transition countries have undergone major political and socio-economic reforms and their public administration systems have been modernized to a significant extent. Such changes also concern their public services, which have played a crucial role in the development of public administration and have contributed to the implementation of the government strategies, particularly in these countries that are still in the process of transforming the role of the state.

The countries in transition have a diverse and rich heritage influenced by the process of obtaining independence and the need to find innovative models of public service. Following their independence, these countries focused on addressing similar systemic challenges stemming from their previous undemocratic regimes, but in doing so they pursued different paths, given their rich but diverse heritage.

This panel aims at providing a comprehensive overview and analysis of public service reform in the aforementioned countries, as well as of the path each country chose in order to transform the prevalent totalitarian systems of governance into democratic ones based on the rule of law, as well as to convert their command-and-control economics into market-based ones.

### **Objectives & Expected Results**

The main objective of the panel session is to analyze the progress made in public service over the past thirty years, as well as to identify the challenges transition countries face and to weigh their prospects in their pursuit for further development. Moreover, this panel session aspires to highlight lessons learnt and good practice in the transition countries' efforts to enhance government agencies capacity, to build an effective, citizen-oriented, and sustainable public administration system, and to adopt adequate legal and institutional frameworks.

In sum, the main expected results of this panel are:

- To consolidate achievements and lessons learnt from public service reform efforts of the past thirty years of the countries in question;
- To identify the most pressing challenges and issues in the area of public service development in the years ahead;
- To develop partnerships for knowledge sharing and mutual benefits.

The core speakers of the panel are experts and practitioners of government agencies and institutions from the following countries: Afghanistan, Belarus, Kazakhstan, Kyrgyz Republic, Republic of Moldova, North Macedonia, and Ukraine.
