Economic growth and confidence are now returning in Europe and employment has also started to recover. However, there is strong divergence in the employment and social situation among Member States. As the demand rebounds, it is clear that the biggest challenge that lies ahead is to restore the economy's capacity to create jobs. The Commission has a threefold mutually reinforcing strategy for jobs and growth: boosting investment, promoting reforms and growth-friendly fiscal consolidation. This approach aims at job rich, inclusive and sustainable growth.
