European Union delivers on its commitments in support of Ukraine

The European Commission and Ukraine signed a number of agreements, further demonstrating the EU's ongoing commitment to Ukraine and to the ongoing reform efforts that Ukraine is undertaking. The agreement supporting Ukraine's public administration reform is worth €104 million, and is one component of a larger package totalling €300 million of EU support for accountable and transparent governance in Ukraine.

EU identifies 20 key deliverables for 2020 for the Eastern Partnership

The European Commission and the European External Action Service have developed a joint working document "Eastern Partnership – focusing on key priorities and deliverables". The document aims to identify 20 key deliverables for 2020, intended to contribute to the joint work of EU Member States and EaP Partner countries and step up actions in four key priority areas: economic development and market opportunities; strengthening institutions and good governance; connectivity, energy efficiency, environment and climate change; mobility and people-to-people contacts.

December infringements package: key decisions

The key decisions taken by the Commission (including 7 letters of formal notice, 77 reasoned opinions, 3 referrals to the Court of Justice of the European Union, and 4 closures) are presented below and grouped by policy area. The Commission is also closing 67 cases in which the issues with the Member States concerned have been solved without the Commission needing to pursue the procedure further.

Schulz, Fico and Juncker sign pledge to make “substantial progress” on key proposals in 2017

The first-ever joint declaration to fast-track a set of EU priority proposals was signed by the presidents of the EU Parliament, Council and Commission on Tuesday. They pledge, on behalf of their institutions, to make “substantial progress” in key policy areas next year. Global, economic, environmental and societal challenges put the European Union at “a critical junction”, the declaration says, and European citizens expect the EU to address these challenges efficiently. Parliament, the Council, and the Commission want to meet this expectation by giving “priority

treatment in the legislative process” to 58 proposals that should “make a concrete difference”.

Already €130 billion delivered into Europe's real economy under the European Structural and Investment Funds

For the first time, the Commission issued a progress report covering the five Funds. It shows a sharp acceleration in investments over the last months, with an implementation expected to reach cruising speed in 2017. By the end of 2015, 274 000 businesses had already received support under the 2014-2020 European Structural and Investment (ESI) Funds; 2.7 million people already had benefitted from assistance in finding a job or developing skills; the biodiversity of 11 million hectares of agricultural land was improved and one million EU-funded projects were selected, for a total value of almost €60 billion.

Your Europe, Your Say! 2017 kicks off

The European Economic and Social Committee (EESC) selected the schools which will be participating in this year's edition of *Your Europe Your Say!*, its flagship event for youth. Their names were selected from over 680 applications at a draw in the presence of Goncalo Lobo Xavier, EESC Vice-President for Communication, and of Katiana Vicens Guillén and Indrė Vareikytė, members of the EESC Communication group. Thirty-three secondary schools, will be involved in this initiative, one from each of the 28 EU Member States and the 5 candidate countries (Albania, the former Yugoslav Republic of Macedonia, Montenegro, Serbia, and Turkey), which will be taking part for the first time.

New Strategic Partnership Framework for Developing Countries with IMF focuses on achieving the Sustainable Development Goals

The Framework focuses on supporting economic institution building, including the design and implementation of macroeconomic policies and structural reforms which are key for achieving the Sustainable Development Goals (SDGs) of the 2030 Agenda. It will be organised around three main pillars including an 'Africa Flagship Initiative' to support economic growth in Africa; a 'Collect More Initiative' to foster revenue mobilization; and a 'Spend Better Initiative' to achieve tangible expenditure outcomes. Upon signing the Framework, Carla Grasso, IMF Deputy Managing Director, made the following statement: "I am pleased to mark this new milestone in our cooperation with the European Commission with the Strategic Partnership Framework. This Framework will leverage our shared vision and core expertise to continue our long track record of working with developing countries as they build sound institutions to achieve sustainable, inclusive economic growth."

The new call, with a budget of €50 million from the European Regional Development Fund (ERDF), will reward the most innovative projects in three categories, in line with the priorities of the Urban Agenda for the EU: the integration of migrants, urban mobility and the circular economy. Under these contracts, some 100 schools are to be built and equipped, benefitting over 70,000 Syrian refugee children primarily in Turkey's Southern and South-Eastern provinces. Johannes Hahn, Commissioner for European Neighbourhood Policy and Enlargement Negotiations said: "The EU continues to deliver on its firm commitment to support Syrian refugees living in Turkey. With the contracts signed today worth €270 million, we will further improve the educational infrastructure on the ground, enabling over 70,000 Syrian refugee children to have access to schooling across the country.
