Foreign affairs MEPs assess reform progress in Albania and Bosnia & Herzegovina

The key political and administrative reforms needed in Albania are progressing, but have yet to reach a stage at which EU accession negotiations could start, said Foreign Affairs Committee MEPs on Tuesday. EU steps up humanitarian assistance for Ukraine by €20 million

The European Commission is increasing its humanitarian response to help people affected by the conflict in eastern Ukraine, with a new humanitarian aid package worth €20 million. European Commission proposes to lift visa obligations for citizens of Georgia

The European Commission is proposing to the Council of the European Union and the European Parliament to lift visa requirements for the citizens of Georgia by transferring Georgia to the list of countries whose citizens can travel without a visa to the Schengen area. <p>Introduction to different negotiation chapters</p>	<p>Antitrust: e-commerce sector inquiry finds geo-blocking is widespread throughout EU Initial findings from the Commission's e-commerce sector inquiry show that geo-blocking is widespread in the EU.
