### **Capping emissions from medium-sized combustion plants**

Proposed EU sulphur dioxide and nitrogen oxide emission limits for medium-sized combustion plants, such as electricity generators or heating systems for domestic, residential or industrial use, were backed by MEPs. They had already been informally agreed with EU ministers. In areas where these emissions breach EU air quality standards, EU countries would be required to assess whether to introduce stricter limits.
