### EU and Andorra finalise negotiations on new tax transparency agreement

Under the new agreement, Andorra and EU Member States will automatically exchange information on the financial accounts of each other's residents from 2018.

The European Commission has made a number of changes to this year's enlargement package, compared to previous years. It confirms the "fundamentals first" approach, highlights the importance of regional cooperation and the connectivity agenda, and addresses the current refugee crisis.

#### **Enlargement package report on Serbia**

Major steps were taken in the accession negotiations with Serbia. The analytical examination of the acquis was completed in March 2015. Serbia completed comprehensive action plans required for the opening of rule of law chapters 23 and 24 and has reached key agreements with Kosovo as part of the normalisation process, dealt with under chapter 35.

#### Key findings of the 2015 report on Bosnia and Herzegovina

The Commission concluded that Bosnia and Herzegovina is back on the reform track and has started to address the outstanding priorities on its EU accession path as demonstrated through the adoption of the Reform Agenda in July. For the country to further progress towards the EU, meaningful progress on the implementation of the Reform Agenda is necessary as a condition for the EU to consider an EU membership application from Bosnia and Herzegovina.

#### 2015 enlargement package report on Turkey

The Report highlights that the EU and Turkey continued to enhance cooperation in the areas of joint interest, which support and complement the accession negotiations. Political dialogue on foreign and security policy continued, including on counter-terrorism, against the background of Turkey joining the international coalition against Da'esh. Cooperation on visas, mobility and migration was pursued in the framework of the visa liberalisation dialogue launched in December 2013.

### European Commission awards €16.43 million in emergency funding to Croatia

The European Commission has awarded an amount of €16.43 million in emergency funding to Croatia to support the country in managing the high influx of migrants and improve the situation on the ground. The funding comes from the Internal Security Fund – Borders and Visa (ISF) and from the Asylum, Migration and Integration Fund (AMIF) which make available €3.99 million and €12.43 million respectively.

### Commission orders Estonia to recover incompatible aid from national air carrier Estonian Air

Following an in-depth investigation, the European Commission has concluded that aid measures by Estonia in favour of national flag carrier Estonian Air gave the company an undue advantage over its competitors in breach of EU state aid rules. Estonian Air therefore needs to pay back the state aid already received, which according to the Commission's information amounts to about €85 million plus interest, and cannot receive an additional €40 million of restructuring aid.

### Education and Training Monitor: More investment needed to spread benefits of education across society

The Education and Training Monitor 2015 shows progress in education attainment across Europe but reveals investment is needed to make education more inclusive and boost social mobility. The 2015 edition of the EU's Education and Training Monitor shows more Member States have now reached their goals in increasing the number of students completing higher levels of education and minimising those leaving education early. This means Europe is on track to reach the targets set in its growth and jobs strategy by 2020. However, this progress is uneven, with discrepancies between and within Member States. Pupils from disadvantaged and immigrant backgrounds are most at risk of not reaching minimal educational standards.

# Flash estimate for the third quarter of 2015 GDP up by 0.3% in the euro area and by 0.4% in the EU28 +1.6% and +1.9% respectively compared with the third quarter of 2014

Seasonally adjusted GDP rose by 0.3% in the euro area (EA19) and by 0.4% in the EU28 during the third quarter of 2015, compared with the previous quarter, according to flash estimates published by Eurostat, the statistical office of the European Union. In the second quarter of 2015, GDP grew by 0.4% in both areas.

#### Parliament is first EU institution to become 100 % carbon neutral

As of 2016, the European Parliament's irreducible carbon emissions can be fully offset, making it the first EU institution to become 100% carbon-neutral, Parliament's Bureau (President, Vice-Presidents and Quaestors), decided some weeks ahead of COP 21 in Paris. At the same time, Parliament is continuing to reduce its carbon dioxide emissions and make better use of energy, water and paper, in line with its environmental policy to first and foremost prevent or limit emissions.

### Budget 2016 deal: Parliament ensures more funding for refugees and jobs

The European Parliament has reached a provisional deal with the Council on the 2016 European budget in the early hours of Saturday.

Parliamentary negotiators fought for more money for the migration, jobs and competitiveness priorities of the Parliament. After budget MEPs and the Council formally endorse the deal, the new budget of the European Union will be adopted at the November plenary session of Parliament. The preliminary figures are €155 billion in commitment appropriations and €143.8 billion in payment appropriations.

#### **EU** finalises proposal for investment protection and Court System for TTIP

The EU has formally presented to the US its proposal for a reformed approach on investment protection and a new and more transparent system for resolving disputes between investors and states: the Investment Court System. The European Commission has finalised its new and reformed approach on investment protection and investment dispute resolution for the Transatlantic Trade and Investment Partnership (TTIP). This follows another round of extensive consultations with the Council and the European Parliament. ### Commission approves new promotion programmes for agricultural products

The Commission has approved 33 new programmes to promote agricultural products. Worth €108 million, these programmes will contribute to opening new markets for EU products and to increasing consumption within the EU. The European Commission has approved 33 new programmes to promote EU agricultural products in the EU and on third country markets. These programmes are worth €108 million over 3 years, half of which (€54 million) comes from the EU budget. The programmes will contribute to opening up new markets and increasing the consumption of promoted products inside and outside the EU. The measures financed can consist of different types of promotional campaigns highlighting the advantages of EU products, especially in terms of quality, food safety and hygiene, nutrition, labelling, animal welfare or environmentally-friendly production methods.
