Planning and Implementation of EU-Ukraine New Enhanced Agreement

Introduction

The new EU-Ukraine treaty (New Enhanced Agreement or NEA), if signed, will not only mark a diplomatic success for Ukraine, but also bring new challenges, of which the overwhelming majority would lie in the domestic rather than the foreign policy area. One can say that implementation of the commitments embedded in NEA will require not only political devotion, but also the design and use of a well-developed planning and implementation system for the already undertaken obligations. Implementation will necessitate capable public administration with a lucid understanding of the acquis communautaire and motivation to "Europeanise" the state. There are few chances to realise the NEA potential within the current European integration framework in Ukraine, which calls for a comprehensive strategic planning (programming) document, integrating a variety of the required implementing activities

and whose ownership would be shared by the entire public administration.

The main elements of the current framework of European integration in Ukraine

The European integration framework in Ukraine is special in that it takes place via parallel tracks (processes) represented by the EU-Ukraine Action Plan (ENP AP) and the National Programme for Legal Approximation (NPLA). While NPLA activities represent a 'voluntary' component, ENP AP is considered to be an obligation of Ukraine before the EU. Legally, the activity of legal approximation is based on a "best efforts" clause and set by the Art. 51 of EU-Ukraine PCA.

Empirically, Ukraine does implement its Action Plan obligations, while the NPLA activities show a poor track record. Furthermore, the day-today application of the adopted legal norms is lagging behind both the Action Plan and NPLA dimensions. For this reason, and because of the increasing complexity of commitments under NEA, a serious European integration system upgrade in Ukraine would be needed. The Ukrainian government has already begun some of the transformations in this direction and it is important not to lose the pace in this process.

Approach to programming for NEA implementation

The author advocates the approach to implementation of NEA via development of a programme akin to the National Programme for Adoption

of the Acquis (NPAA will be explained further). It provides for increased transparency of the whole process and better coordination for keeping the status quo. If a single approach to financing is chosen (now there are different financing modalities within the legal approximation programme and implementation of ENP AP), this would provide for even more financial transparency, ease targeted activity financing and streamline monitoring and evaluation.

The NPAA-type programme was used in all countries joining the EU. As for Ukraine, even if it has not been given a clear EU perspective, NEA provisions would go quite far in terms of economic integration into a single EU market. Finally, an NPAA-type programme makes the whole planning (and implementation) system more manageable by a single body, which, according to the government programme "Ukrainian breakthrough: for people and not for politicians" should meet the goals of the Ukrainian government.

Programming element of the strategic approach to European integration: National programme for adoption of the acquis (NPAA)

The core of the planning process is a strategic document (i.e. NPAA) that was developed by almost all "association" countries' governments. One can exemplify NPAA structure, based on the example of the respective Polish document. It is based on the Copenhagen and Madrid Councils' EU membership criteria. One of the Polish NPAA sections – 'Ability to assume the obligations of membership'

contains the *acquis communau-taire* and corresponding national transposition and implementation measures relevant to the Ukrainian NEA (deep free trade area) implementation. As this article focuses on legal approximation, it will further highlight only this section of NPAA.

Polish NPAA provides for a **typical structural component** used in the chapter 'Ability to assume the obligations of membership'. The example below uses the *acquis* section 'Free Movement of Goods' which is the first priority in the chapter.

Structure of Priority 1 'Free Movement of Goods' chapter of Polish NPAA

Priority 1. Adjustment of Polish Legislation in the Area of New Approach Directives

This priority consists of 2 main parts as follows:

- 1. Description of the background of the priority and textual presentation of the general actions to be undertaken.
- 2. Detailed description of methods of implementation according to the table below.

As can be seen, legal harmonisation is not only about the adoption of laws by Parliament. In the case of Poland, some EU directives were transposed by Governmental ordinances. Generally, implementation requires mobilising the full range of normative tools. At the same time, NPAA per se does not normally go deeper than specifying laws/ ordinances and particular activities. When the aim of activity is established, line executives (ministries) have discretion in the method of implementation, as long as they provide for full implementation.

Preparation and implementation of NPAA - Polish experience

The Polish NPAA was designed when accession negotiations with the EU were underway. This situation is not equivalent to the current EU-Ukraine relations. However, as the level of

detail of the EU-Ukraine Action Plan is already comparable to Accession Partnership provisions (which are based on the Europe Agreement³), Polish NPAA is relevant for Ukraine. NEA provisions would probably go even deeper – closer to Accession Partnership dispositions, which were key to Polish accession negotiations.

Polish priorities for the implementation of the *acquis communautaire* were reflective of the

White paper "Preparation of the Associated Countries of Central and Eastern Europe for integration into the internal market of the union" (1995), created with the participation of the Member States. Providing for short-, medium- and long-term objectives of the Polish administration, it became the first road map in the integration process.

NPAA preparation was coordinated by UKIE⁴, whereby every ministry elaborated its own element of the programme, including background information and tables of measures

and thereby assuming corresponding commitments. Line ministries prepared parts of the programme according to their policy-making competences. Authorities regularly revised NPAA for precisions and amendments. Twice a year, Poland provided information to the European Commission before the Commission issued its reports.

Elaboration of the Polish NPAA was not aided by any permanent EU technical assistance project. At the same time, a number of EU consultants were always available through the European Commission's Delegation representation in Warsaw. Many capacity building activities for line ministries took place to assist in the preparation of drafts of the respective parts of NPAA.

The different parts of the Polish NPAA were consulted upon with the European partners during sub-committee meetings, which are similar to the current setting in Ukraine, where Action Plan measures are agreed at the level of the EU-Ukraine Co-operation Committee's sub-committees.

Poland adopted two types of structures to make European integration work: (1) departments of European affairs in every ministry charged with the coordination of European integration activities; (2) inter-ministerial task forces (formed due to the multidisciplinary nature of many issues which required not only internal, but also external, expertise in different fields). Thus during NPAA implementation, many task forces were created for specific sectoral and inter-sectoral issues. They consisted of the representatives of the relevant state bodies and external experts. The task forces were responsible for drafting (sets of) legal acts. UKIE

agreed the working timetable with both line ministries and all task forces. The approach was to analyse a particular piece of the *acquis*, define which fields it belonged to and then compose a task force (intra- or interministerial) including professionals or quick learners able to solve a particular problem. Whenever experts participated in the drafting of task forces, they had only a consultative status.

UKIE representatives (including its Secretary) had frequent meetings with line ministers and line ministerial staff regarding implementation. One line of communication and assessment took place in writing: what was agreed, what has been done, are there any lags in implementation, and why was it so. Apart from that, the UKIE Secretary also met line ministers and ministerial staff personally (in a group). When ministries did not comply with the preliminary agreed deadlines, they were held responsible for the problem (via the prime-ministerial channel if necessary). This system worked relatively efficiently.

A powerful tool used in the process of the *acquis* implementation was a requirement for line ministries to prepare drafts of all the necessary secondary acts, as a package to be used for the implementation of a draft law. This method is characterised by heavy supplementary drafting needs and thus was not popular among civil servants. However, occasional usage of this requirement can be justified.

During EU accession, Poland made use of a system of compliance checks with the *acquis communautaire*. Overall it was similar to the current Ukrainian system. However, unlike today's Ukraine, the Polish non-compliance was considered a block

on the way to accession and, as such, was taken much more seriously.

Recommendations as to organisation of planning and implementation processes in Ukraine

NPAA-type programme

In order to successfully implement NEA provisions, the Ukrainian government will develop an NPAA-type programme that will provide for a very clear mandate for domestic reforms and a reference point for any (successive) government (governmental programme) taking into account the following:

- NPAA-type programme should become the programme of domestic reforms, a reference point for any (successive) government (governmental programme). NPAA should provide for a very clear road map and for a possibility to adjust it according to the dynamics of EU-Ukraine relations, decisions of EU-Ukraine bilateral bodies and the individual priorities of Ukraine.
- NPAA-type document requires financial estimations, at least on the level of forecasts. Rough estimates as to the resource needs of different reforms and measures can be taken from NPAA documents of other countries (e.g. Poland, Turkey).
- It is necessary to link NPAA tasks with all the available opportunities to engage technical assistance resources from the EU, MSs and other national and international donors.
- Currently 80 to 90 % of all the new laws regulating economic activity in Poland relate to the acquis communautaire.

 While in case of Ukraine and



its 'less binding' obligations this ratio may be smaller, acquis communautaire should become an important point of reference in Ukraine during any drafting process in economic domain.

Administrative structures for acquis implementation

It is important to ensure an understanding of NEA implementation planning by public servants. The available supplementary materials from the European Commission may facilitate this task. For instance, a reference (catalogue) on 'typical' administrative structures, required for implementation of the acquis communautaire, can be used. This document was compiled on the eve of EU enlargement of 2004 and should serve as a solid point of reference⁵. There is a chance that a fresher version of this document will feature in EU-Croatia negotiations.

Planning

Implementation of NEA places significant expenses on the Ukrainian government, certain categories of market participants and on low-income consumers. However, efficient use of sequencing, transitional periods and the EU technical assistance allow a decrease in such costs. Therefore, the rational approach dictates analys-

ing the *acquis* offered for implementation and investigating both impacts and inter-relations between their norms, followed by development of an implementation scenario. Regulatory impact assessment serves as an essential tool here.

Implementation of NPAA should not require separate action plans, as NPAA itself serves this purpose directly. This further increases the importance of sufficient participation of the executive bodies which will later implement the planned measures. Overall, such involvement is required at all stages: negotiations, programming for implementation and implementation itself.

Implementation of NEA

The enormous investment requirements brought about by the implementation of the EU norms can be significantly reduced in the case of a well-thought-out involvement of business. In this sense, an improved version of PPP law is crucial.

The introduction of the mandatory requirement to draft a package of secondary legislation, together with draft laws, provides a strong impulse for improving implementation. However, as this might impose a heavy burden on bureaucracy, the Ukrainian government should consider a selective application of this requirement

– for the areas which exhibit the biggest lack of implementation.

An additional way to 'rationalise' implementation of NEA is to achieve the best synergy possible between WTO compliance activities and EU norms' implementation. While conducting planning for NEA implementation, one should take into account that implementation of the deep free trade area component of NEA may, at least partially, coincide with the WTO commitments' implementation. In order to be more precise here, it is necessary to analyse a working party document of Ukraine on the accession of Ukraine to WTO.




